No kittens under the age of 4 months will be allowed in the show hall. ONE BENCHING REQUEST PER EXHIBITOR WILL BE HONORED, IF POSSIBLE, AND MUST BE MADE AT TIME OF ENTRY.

**Benching will be from 7:30 to 8:30 am on Saturday with judging to start at 9:00 am.** Any cat(s) not checked in by 8:30 will be marked absent. No veterinary inspection required prior to benching. Cats should be inoculated against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), rhinotracheitis, calici and rabies. It is strongly recommended that all be tested and found negative for FeLV. **All** claws must be clipped prior to benching. **Advertised show hours are 9:00 am - 5:00 pm on Saturday and 9:00 am - 4:00 pm on Sunday.** No watchman will be on duty Saturday night. The Club will take all reasonable care of personal property but will not be liable for loss or damage. Show hall is handicap accessible. **Handicap benching (end of row) is available upon request at no extra charge.** No refunds for failure to bench. Litter will be provided, bring your own boxes. People food will be available. Hall is air-conditioned. No alcoholic beverages are permitted. Rosettes will be awarded per CFA rules. Permanent flats will be used - cloth ribbons available. Cage size is 22" x 22" x 22" (single). Map and motel information sent with confirmation. Exhibitors are responsible for their own transportation. Flying in - use Cleveland Hopkins Airport.
